NANNY APPLICATION

This is a request for Nanny privileges at Paradise Country Club for the person named below who will care for my (our) children in our absence. I (we) understand that:

- The Nanny must be eighteen (18) years old or older;
- Certification of the Nanny's age is required; two LEGIBLE copies of his/her driver's license must be provided and shall be attached to this completed Application;
- Each Membership/Family is to hire its own Nanny for the care of its children; two or more families may not share a Nanny;
- Each Membership/Family is allowed only one Nanny per day; not two, as in the case where Grandparents might be registered as Nannies. Only one Grandparent may be the Nanny on any particular day, the other Grandparent would visit the Club as a Grandparent and pay the \$2.00 Grandparent Guest Fee;
- The Nanny Fee is \$2.00 per day or \$25.00 for the season;
- The Nanny MUST stop at the Gatehouse at each visit to register as a nanny on the Club property, and to, verify that he/she is listed as an approved Nanny. The member's name and his/her name must be provided to the staff at the Gate.
- The Nanny will be asked to show his/her driver's license for identification; The Nanny may be at the Club only in my (our) absence;
- If the Nanny is on the Club property with the parent(s), the Nanny must be registered as a guest and the appropriate guest fee must be paid; all guest rules and regulations apply, including applicable fees and a limit of 5 guest visits per season;
- The Nanny is NOT a member of the Club and is not entitled to any membership privileges;
- The Nanny may NOT bring a guest or guests to the Club; if the Nanny arrives with a guest or guests, my/our children and the Nanny (plus guest) will be denied access to the Club property;
- I/We, the Member(s), MUST complete an Emergency Information Card for each child which will be kept on file in the Guard Shack;
- One Guest will be allowed to accompany the Member's/s' children to the Club while they are in the care of a Nanny. The following procedures must be adhered to:
 - The children of a family membership may bring ONE guest to the Club on a particular day when those children are cared for by their Nanny;
 - The one guest must be a friend of the child (or one of the children) and not a friend or relative of the Nanny. This guest must be a child under 15 years of age;
 - The adult members of the family membership, or the single adult member of the single family membership, must have his/her/their signature(s) on file in the Gatehouse for reference; please stop by our Gatehouse at your convenience to place your signature(s) on your family's Nanny Card;

TWO (2) CLEAR AND LEGIBLE COPIES OF THE NANNY'S DRIVER'S LICENSE ARE REQUIRED WITH SUBMITTED APPLICATIONS. THE PHOTOGRAPH, NAME, ADDRESS, AND DATE OF BIRTH MUST ALL BE CLEAR ON THE COPIES.

THE APPLICATION CANNOT BE APPROVED IF THE COPIES ARE NOT CLEAR AND LEGIBLE, IF ANY INFORMATION IS MISSING FROM THE APPLICATION; OR IF THE NANNY AND BOTH ADULT MEMBERS HAVE NOT SIGNED THE APPLICATION.

EMERGENCY MEDICAL INFORMATION CARDS ARE INCLUDED WITH YOUR NANNY APPLICATION ONE MUST BE COMPLETED FOR EACH OF YOUR CHILDREN THEY WILL BE KEPT ON FILE IN THE GUARD SHACK

PLEASE ALLOW THREE (3) DAYS FOR APPROVAL OF THE APPLICATION

THE NANNY WILL NOT BE PERMITTED ON CLUB PROPERTY WITH YOUR CHILDREN UNTIL THE APPLICATION IS APPROVED.

FOR IDENTIFICATION PURPOSES, THE NANNY WILL BE ASKED TO SHOW HIS/HER DRIVER'S LICENSE AT THE GATEHOUSE UPON ARRIVAL. PLEASE MAKE YOUR NANNY AWARE OF THIS SO THAT DELAYS AT THE GATE ARE A VOIDED.

THE MEMBERS AND THE NANNY SHOULD READ THE NANNY APPLICATION CAREFULLY AND COMPLETELY.
